- Prize fund returned 100%. Prize ratio will be 1:4 for doubles.

2018-2019 Greater Charlotte USBC Association Mixed Doubles Tournament Rules

1. The Greater Charlotte USBC Association (GC USBC) Mixed Doubles Tournament is certified by USBC and will abide by its rules and those stated in regard to this tournament.
2. This is a doubles handicap tournament open to all bowlers who are members of the GR Charlotte USBC. Entrants must present their 2018-2019 USBC membership cards prior to participation. **Doubles teams must consist of one male and one female.**
3. Non-members must purchase an associate card (\$20.00) prior to the start of bowling, unless verified by the Tournament Manager.
4. **Average Requirement:**
 - a. Highest USBC certified winter or summer yearbook average based on 21 games or more for the 2017-2018 season.
 - b. A bowler with no 2017-2018 yearbook average or summer 2018 average shall use their current average (based on 21 games or more) as of October 21, 2018. Proof of average must be provided with entry. If neither (a) nor (b) Bowler will bowl scratch.
 - c. A bowler is required to report any previous tournament adjustment/rerate.
5. Bowlers who have qualified for a prize of \$300 to \$1000 in any tournament (certified or non-certified) in the past 12 months shall report the amount of prize and score for possible re-rating. Such re-rating must be accomplished before the entrant may bowl. If re-rate is not acceptable by the entrant, the entry fee will be refunded. If winnings of \$1000 or more are not reported the bowler will be disqualified. Rule 319d-a
6. It shall be the bowler's responsibility to verify the accuracy of their average prior to the start of the tournament. Failure to use proper average will disqualify bowler.
7. Handicap will be 90% of 220.
8. All prize fees collected will be returned 100% to participants.
9. Confirmations will be sent by regular mail.
10. Mailed entries must be postmarked on or before October 21, 2018.
11. Walk-ins will be allowed (cash only) provided they have registered by 8:30 AM on the day of the tournament (No Exceptions),
