- Acts of contribution in supporting our great sport on or off the lanes
- Should be a certified bowler in the Greater Charlotte USBCA

A nomination may be made by an individual, including the nominee, or group of individuals, providing it has the written endorsement of at least one sanctioned bowler or group other than the nominee.

No more than one candidate may be elected each year. An annual selection is not required.

The award may be presented posthumously.
