The entrants whose names appear hereon or their authorized replacements hereby agree that the Greater Charlotte USBC Association, its officers and directors shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling in any event in the tournament through premature termination of this tournament, which may be brought about by war, national emergency or emergencies or cause relating thereto or resulting from fires, strikes, lockout, labor difficulties or their causes beyond the control of the Greater Charlotte USBCA.

2019 - 2020 Greater Charlotte USBC Association Open Tournament Rules

1. The Greater Charlotte USBC Association (GC USBC) Open Tournament is certified by USBC and its tournament rules are applied as well as those listed below.
2. Eligibility:
 - a. All members of the GC USBC with proof of membership required at check-in; or
 - b. Non GCUSBC Association members must pay applicable national and/or state and/or local dues. (Associate card fee is \$20.00; USBC dues -\$13.00, N.C. states dues - \$1.00, and local dues - \$6.00.)
 - c. No more than two (2) current professional members shall bowl on one team and not more than one (1) on a doubles entry.
 - d. Unmarried, grade and high school students who have not attained the age of 18 must have the written consent of their parents or guardian to participate in an USBC certified tournament and this consent form must be on file prior to the start of bowling.
3. Average Requirement:
 - a. Highest USBC certified winter or summer yearbook average based on 21 games or more for the 2018-2019 season.
 - b. A bowler with no 2018-2019 yearbook average or summer 2019 average shall use their current average (based on 21 games or more) as of January 1, 2020. Proof of average must be provided with entry. If neither (a) or (b) bowler will bowl scratch.
4. All bowlers will be required to adjust their average if they meet the criteria of USBC Rules 319a thru 319e. Bowlers who have qualified for a prize of \$300 - \$1000 in any tournament (certified or non-certified) in the past 12 months shall report the amount of prize and score for possible re-rating. Such re-rating must be accomplished before the entrant may bowl. If re-rate is not acceptable by the entrant, the entry fee will be refunded. If winnings of \$1,000 or more are not reported the bowler will be disqualified. Rule 319d-a.
5. There will be a handicap division for teams, doubles & singles; as well as optional all events handicap and scratch.
6. Handicap shall be 90% of 220.
7. Team Composition:
 - a. Teams will be composed of four (4) members (all men, all women and/or mixed).
 - b. A bowler may bowl on as many teams as they want, but no more than two (2) bowlers can compete together on more than one (1) team. Bowlers can only enter doubles & singles once.
 - c. Bowlers are only allowed to enter optional all events once. The first team score, along with the bowler's doubles and singles scores counts for the bowler's all events
 - d. Bowlers shall bowl doubles and singles on the same squad.
 - e. Doubles event is bowled first. No switching of lanes between doubles and singles.
8. Entry deadline: March 15, 2020. Mailed entry form and all fees must be submitted at time of entry and postmarked no later than March 15, 2020. Squad times are scheduled on a first come, first serve basis. There will be no change in the line-up once entry is accepted by the Tournament Manager.
9. Prize Ratio: Prize fee is returned 100%; one for six (1:6) for Team, Doubles and Singles; and one in ten (1:10) for All Events handicap and scratch.
10. In case of a tie for the championship in any event, co-champions will be declared (USBC Rule 326a). Prize fees paid into each event shall be returned 100% to the winners in that event only.
11. Individuals must check in with photo ID, along with any needed substitutes at least one (1) hour prior to scheduled squad time. Substitute averages are governed by tournament rules 2 and 3.
12. Lanes will be redressed between squads.
13. Payment:
 - a. Personal checks are accepted, one per entry.
 - b. Make checks payable to: Greater Charlotte USBC.
 - c. Checks returned for insufficient funds will have a \$25 fee added. Full payment of the entry fees and return check fee must be done, in cash or certified check, no later than one (1) hour prior to start of scheduled first event in order to compete.
14. Confirmations to be sent by email or US Postal Service.
15. Entrants are expected to wear proper attire when participating in the GR Charlotte Open Championship Tournament.
